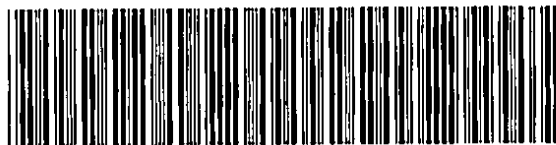

**CERTIFICATE OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
THE PATIO HOMES OF SOUTH SHORE VILLAGE HOMEOWNERS ASSOCIATION,
INC.**

The Articles of Incorporation of The Patio Homes of South Shore Village Homeowners Association, Inc. were filed with the Secretary of State on November 29, 1993.
