2. Article XI is hereby amended to read as follows:

AMENDMENT OF ARTICLES OF INCORPORATION: These Articles may be amended by the owners of two-thirds (2/3rds) of the Units present and voting at any regular Annual Meeting of the Corporation provided, however, that these Articles of Incorporation shall not be amended unless written notice is first given of the proposed Amendment to each and every member of the corporation, not less than ~~fifteen (15)~~ fourteen (14) days prior to the regular annual Meeting of the Corporation; such notice shall be sufficient, if it is published not less than ~~fifteen (15)~~ fourteen (14) days prior to the regular Annual Meeting of the Corporation, in such publication as may be designated by the Board of Directors as the official journal of the Corporation.
