ARTICLE III - SPECIFIC PURPOSE

The purposes for which this corporation is organized are as follows:

- 1) To operate as a corporation not for profit pursuant to Chapter 617 of the *Florida Statutes* and organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 2) To operate as a non-profit church and Christian air transportation ministry, whose purpose is to serve the Christ-centered community of the southeastern United States, Bahamas and Caribbean.
- 3) The objective is to serve the Lord by sharing his life-giving hope of salvation with others and providing point-to-point general aviation transportation by small aircraft for personnel, missionary, medical supplies, food, and mercy flights.
- 4) To train missionary pilots and mechanics and to provide home and foreign missionary aviation services to their respective communities.
- 5) To engage in any other not for profit activity or business permitted by the laws of the United States and the State of Florida.

Attachment #2 Amendment to Add Article VIII to Articles of Incorporation

ARTICLE VIII - Dissolution

1) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.
