## AMENDED AND RESTATED ARTICLES

- 1. The Articles of Incorporation of Miami Beach Community Kollel, Inc., a Florida not for profit corporation created pursuant to Chapter 617 of the Florida Statutes, were filed on January 12, 1994.
- 2. Subparagraphs (b) and (d) of Article VIII of the Articles of Incorporation are hereby amended and restated in their entirety to read as follows:
