Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment adopted:

1. **Name of Corporation.** The present name of the Corporation is MIAMI JUNIOR ICE HOCKEY LEAGUE, INC. The name of the Corporation is hereby changed to SOUTH FLORIDA YOUTH HOCKEY ASSOCIATION, INC. Article I of the Articles of Incorporation is amended to read as follows:
