
This is to follow-up on my telephone conversation with Shawn on
Friday, March 20, 1998 regarding Lavender Magic a non-profit
corporation in the State of Florida.

We received notice from your department that the corporation had been
dissolved because the statutory 1997 filing had not been completed.
When I discussed this with Shawn he indicated that your Department had
received our original filing in June 1997 and returned it for correction.
We were unaware that the filing had been rejected, therefore taking no
further action with the assumption that we had satisfied the State's
requirements.

Per Shawn's direction, enclosed you will find a completed Application
for Reinstatement and a check totaling \$ 131.25. This amount should
cover the annual filing fee for reinstatement in 1997, the required filing
fee for 1998 and the Certificate of Status fee. Shawn indicated that the
Department would waive the reinstatement fee of \$175.00 since the
