# AMENDMENT TO ARTICLES OF INCORPORATION OF BASEBALL BOOSTER CLUB, INC.

PURSUANT to the provisions of the Florida Statutes, BASEBALL BOOSTER CLUB, INC., a nonprofit corporation organized and existing under the laws of the State of Florida, hereby files this Amendment of Incorporation, thereby making the following changes:

A. ARTICLE I is confirmed to be as follows:

## ARTICLE I. NAME

The name of the corporation is:

BASEBALL BOOSTER CLUB, INC.

B. ARTICLE II is amended to be as follows:

The general purpose of this corporation, together with and in addition to the authority conferred by the laws of the State of Florida, is for youth development, but limited to the following activities:

- 1. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- 2. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- 3. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt

the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### C. ARTICLE VII is amended to be as follows:

The business of this corporation shall be managed by the Board of Directors. This corporation shall have four (4) Directors, initially. The number of Directors may be increased from time to time by the By-Laws, but shall never be less than three (3).
