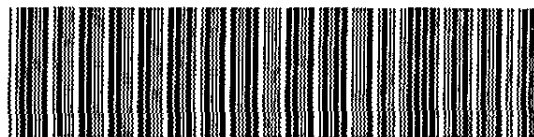

Enclosed is our check in the amount of \$96.25 for the following:


