To Whom It May Concern:

This correspondence is in response to your notification of administrative dissolution or revocation of the corporate status of the above noted condominium complex. Upon receiving this notification, I contacted your office and spoke with "Michele", she stated that I needed to submit the following information in writing to you, along with a check for \$61.25.

Information: In April of this year, the Registered Agent for our complex, Ms. Sylvia Gentile, residing at 2825 NW 104th CT #D, Gainesville, FL 32606, sold her unit and moved out of town. At that time, I, Jean Powell, residing at 2825 NW 104th CT #A, assumed the duties of Ms. Gentile. Ms. Gentile advised me that all bills were paid through December 31, 1999, and that there would be nothing due until after the first of the year, and that I would receive notification in the mail prior to due date of official fees or dues.

To date, I have not received any notification to me regarding our corporation status, including any fee requests.

My neighbor, who bought Ms. Gentile's condo did receive the recent sent Notice of Administrative Dissolution or Revocation, which he brought to me.

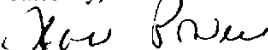
Ms. Gentile's condo was vacant for a short time, and I assume the information previously mailed from your office went to her address, instead of mine. And the Dissolution notice sent recently went to Ms. Gentile's condo address, instead of mine, and luckily, the condo is no longer vacant, and the occupant brought it to me.

Due to this mix-up, Michele advised me to send in the \$61.25 annual fee, which I have enclosed. I have also requested a Certificate of Status and included the \$8.75 in my check.

I am concerned however, that the mail from your office is going to her address and not to mine. I see on the Application that the principal place of business and mailing address are listed as "D" and not "A". I have revised the application form to reflect updated information.

Please advise if further information is required.
