Dear Sean,

Per our TelCon today, I am returning to you the paperwork returned to our organization including the second check and this letter reiterating our predicament.

With the paperwork package is a sheet showing copies of our check stubs from Jan 10 to Mar 05, 1996. The check on the top left column (number 344) was written to the department of State (Florida) for Corporation renewal for \$61.25 on Jan 25<sup>th</sup>, 1996.

I remember our Treasurer reporting that the check had not cleared a couple of months later, but we decided that it was delayed by governmental procedures, etc. Apparently around the end of August a *Notice of Administrative Dissolution or Revocation* was sent to, our then President, Chet Holloway. He presented this at a meeting seeking direction for the organization in this matter. It was suggested to return the application with proof that we had attempted to file on time, in fact, early and that the check was lost at some point and to make our effort at rectification by including a new check, number 370 (attached). This was dated Oct 12<sup>th</sup>, 1996. Apparently a letter of explanation was not included.

The entire package of Nov. 12 was returned with a letter (Ref. No: N94000001490) (letter No: 296A0053132) from Stacy Prather citing a requirement of an additional \$175 for reinstatement.

As mentioned, I am trying to prevent dissolution by correcting an effort of compliance gone awry rather to reinstate a dissolved corporation. It was our mistake in the first place, I guess, not to have sent our official paperwork registered, return receipt. But you can be assured we will use that measure in the future as insurance. In the second place we must not have plainly explained the facts from our view. I wish to reiterate that we feel that we initially complied fully, and well before deadlines for the continuance of our corporation. We have no idea where the original package may be, but should it turn up we would appreciate the original check, number 344, being destroyed or returned.


