The following amendment of the Articles of Incorporation was adopted by a majority vote of the Board of Directors of the Corporation on June 3, 1997, in the manner prescribed by the Articles and By-laws of the Corporation and the Florida General Corporation Act. This amendment was adopted by all the members on June 3, 1997.

1. RESOLVED, That the Articles of Incorporation of this Corporation, dated April 4, 1994, and filed in the office of the Secretary of State of the State of Florida on April 8, 1994, be amended so as to change the name of the said Corporation from ST. MARK EDUCATIONAL CENTER, INC. to ORANGE AVENUE CHARTER SCHOOL, INC.

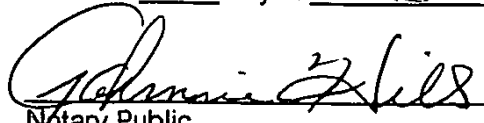
