ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

LEWIS FOUNDATION, INC., a not for profit corporation organized and existing under the laws of the State of Florida (the "Corporation"), hereby certifies as follows:

- 1. The name of the Corporation is Lewis Foundation, Inc. The date of filing of its original Articles of Incorporation with the Secretary of State was April 18, 1994.
- 2.
