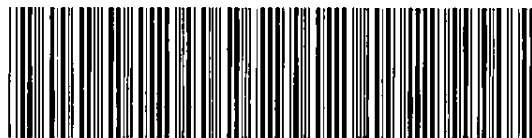

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment to its Articles of Incorporation:

Amends Article 4, Purposes and Powers. The original Article 4 is amended to read in its entirety as follows:

Article 4
(Purposes and Powers)

The purposes for which this corporation is organized are:

(a) The primary purpose of this corporation is to provide activities that contribute to the development of good character or good sportsmanship, or to the educational or cultural development, of minors.

(b) To contribute to the educational development, cultural development, good character, or good sportsmanship of minors by providing minors participating in home education programs with periodic classroom opportunities, field trips, park meet-ups, and other educational or social programming and activities in support of the primary purpose, and to provide information and education to parents of said minors about home education programs to aid in the educational and cultural development of minors or the development of good character or good sportsmanship of minors.


(c) To have and to exercise all authority, rights, and powers conferred upon not for profit corporations under the laws of Florida generally, including but not limited to those powers provided in Sections 617.0302 and 617.0303, Florida Statutes.
