ARTICLES OF INCORPORATION

POR

ST. JOHN PROGRESSIVE MISSIONARY BAPTIST CHURCH INC. A FLORIDA NON-PROFIT CORPORATION

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: ST. JOHN PROGRESSIVE MISSIONARY BAPTIST CHURCH INC..

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The address of the principal place of business and the mailing address of this corporation shall be: ST. JOHN PROGRESSIVE MISSIONARY BAPTIST CHURCH INC., 2504 Chipco Avenue Tampa fl. 33605 or P.O. Box 75194 TAMPA, FLORIDA 33675.

ARTICLE III PURPOSE(S)

The specific purposes of this corporation are: to conduct, religious worship and instruction; to operate a church, religious school and other institutions connected therewith, of a religious, educational, charitable and benevolent character, to the end that its own members and others may be generally instructed and guided in the form of worship prescribed by The New Testament and to advance spiritual growth and enlightenment, moral and personal purity among its own membership and the people of the community in which it is located.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as following: The Directors of this corporation shall consist of the Pastor as President, and the board of Deacons as Directors. With exception of the Pastor as President, all Deacons as directors shall be elected on Thursday night preceding the first Sunday in November of each year in accordance with the churches constitution and bi-laws. The Pastor is called in accordance with constitution and bi-laws thus is not elected annually.

ARTICLE V LINITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes.

ARTICLE IX INDEBTEDNESS

The highest amount of indebtedness of liability to which the corporation may at any time subject itself, which shall never be greater that two-thirds or the value of the property of the corporation.

ARTICLE X MISCELLANEOUS

(a) All conveyance by the corporation shall be signed in its name by the President (Pastor) or Vice President Chairman of Deacons and the Church Clerk. The conveyance shall also bear a corporate seal which shall consist of two concentric circles with

the words "St. John Progressive Missionary Baptist Church" between them, and the words "Tampa, Florida", within the inner circle.

- (b) With the exception of President, (Pastor) the election for officers of the corporation shall be held at the Church at 8 o'clock on Thursday preceding the first Sunday in November and on the same day of each succeeding year except when said day falls upon a holiday, in which case the election shall be held on the next succeeding day. In the event a meeting at which time election of officers is being held continues to midnight, the meeting shall be promptly adjourned by the presiding officer at 12 'clock midnight until the next succeeding night, at which time business at hand shall continue.
- (c) In all matters not hereinabove specifically enumerated, the corporation shall follow the rules prescribed by the Constitution & By-Laws of St. John Progressive Missionary Baptist Church and all disputes will be settled in line with the New Testament.
