TEAMFL HELPING ADVANCE NEIGHBORHOODS, KIDS AND SCHOOLS (T.H.A.N.K.S.), INC., a corporation not-for-profit organized and existing under and by virtue of the Florida Not For Profit Corporation Act (the "Corporation"), does hereby submit for filing these Articles of Dissolution pursuant to Section 617.1402, Florida Statutes, and

DOES HEREBY CERTIFY THAT:

- FIRST: The name of the Corporation is "TEAMFL HELPING ADVANCE NEIGHBORHOODS, KIDS AND SCHOOLS (T.H.A.N.K.S.), INC."
- SECOND: The Articles of Incorporation of the Corporation were filed on May 27, 1994 under the Corporation's original name, ORLANDO-ORANGE COUNTY EXPRESSWAY AUTHORITY FOUNDATION, INC., and assigned document number N94000002762.
- THIRD: The name of the Corporation was changed to its current name by virtue of an Amendment to the Articles of Incorporation filed on January 23, 2002.
- FOURTH: The dissolution of the Corporation was approved by a majority vote of the Board of Directors on October 13, 2010, and such vote was sufficient for approval.
- FIFTH: Adequate provision has been made for all of the debts, obligations and liabilities of the Corporation pursuant to Section 617.1402, Florida Statutes pursuant to the Plan of Distribution attached hereto and incorporated by reference herein.
- SIXTH: All of the remaining property and assets of the Corporation have been distributed to duly qualified not-for-profit charities in the State of Florida.
- SEVENTH: There are no suits pending against the Corporation in any court.
- EIGHTH: These Articles of Dissolution of the Corporation shall be immediately effective upon filing with the Florida Department of State, Division of Corporations.
