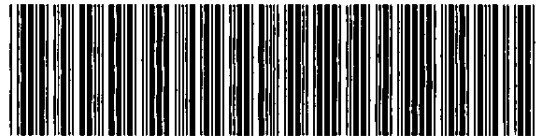

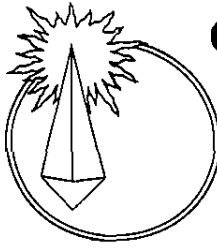

**Plan for Distribution of Assets**

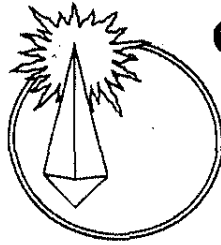

Assets include the following: stock certificates in a Merrill Lynch account, cash in a Riverside Bank checking account, residual inventory from the book store, electronic audio equipment, office equipment, decorations and furniture. Residual inventory has been stored in a climate controlled facility. Costs for storage has been partially paid by Rev. Robert Buck. Reimbursement of those costs will be rendered.
