Amend first paragraph of Article III – Membership, to read:

"To qualify for membership, one must believe that Jesus is the Christ, the Son of God, and their Savior. Further, they must publicly confess their faith by being baptized by immersion in the name of Jesus Christ for the remission of their sins and receipt of the Holy Spirit. One who has previously confessed their faith and been so baptized may be admitted by statement of this fact."

Amend Article VIII - Amendments to the Charter, to read:

"These Articles of Incorporation may be amended by resolution first adopted by a two-thirds (2/3) vote of the Board of Directors of the corporation who are present at a duly convened meeting of the Board of Directors. If any member of the Board of Directors at such meeting shall object to immediate action thereon, then such proposed amendment shall be deferred to the next meeting of the Board of Directors, at which time action shall be taken thereon. Such resolution must be subsequently approved by two-thirds (2/3) vote of the members of the corporation in attendance after notice has been given to the entire membership of the corporation in the manner and time stated in the By-Laws. Such amendment to the Articles of Incorporation shall not be effective until a true copy of such resolution, as well as a certificate of the Secretary of the corporation that the provisions of these articles have been complied with and have been duly filed with the Secretary of State of Florida in the manner provided by law."
