ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

RISING STARS EDUCATION & SPORTS FOUNDATION, Inc.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST:

Article I: Name of Corporation: Amendment adopted: October 30th 2008

Amend name of the corporation from Rising Stars Education and Sports Foundation, Inc. to:

AID FOR ABUSED CHILDREN

SECOND:

Article II: Amendment adopted: October 30th 2008

Principle Place of Business

The activities of Aid for Abused Children shall maintain its principle office to 122 Calistoga Road #200 Santa Rosa, CA. 95409, in Northern California. It may also have offices at such other places as the activities of the Corporation may require. Such address may be changed from time to time by the Board of Directors of the <u>Aid for Abused Children</u> without amendment to these articles.

THIRD:

Article III Purpose of Business Amendment adopted: October 30th 2008

New Purpose Statement:

This Corporation is organized exclusively for charitable, religious, educational and literary purposes, including for such purposes, the making of distributions to organizations under section 501 (C) (3)of the Internal Revenue Code, or the corresponding section of any future tax code. The primary purpose of this corporation shall be to provide basic human needs to children, women, families and communities, particularly (but not limited to) those affected by suffering poverty, poor health, insufficient education and victims of human trafficking, by providing or supporting programs that deliver food, clean water, health care, abused and abandoned children's care and housing, educational, vocational, training and mentoring, equipping them with the means to transition to sustaining their own lives through business enterprise. In addition the corporation shall carry on other charitable and educational activities associated with these purposes as allowed by law.

FOURTH:

Article V Dissolution of Corporation, Amendment adopted: October 30th 2008

Upon the dissolution or winding up of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all the liabilities of the corporation, distribute all of the assets of the corporation to such organization or organizations organized and operated exclusively for charitable purposes as shall at the time qualify as an exempt organization or organizations under the Section 501 (C) (3) of the Internal Revenue Code of the 1954 (or the corresponding provision of any future United States Internal Revenue Law) As the Board of Directors shall determine.
