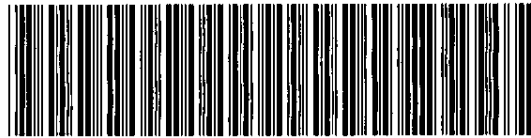

is by a super-majority of the school board of 4
of the 5 members, which includes the superintendent.

chosen annually along with the vice-chair

regularly monthly scheduled unless waived
by resolution in previous meeting by
