Amendment to ARTICLE III Purposes:

Through care, concern, and evangelism, this Church will reach out to its community and to the world through its missionary commitments.

An additional corporate purpose of this Church shall be to extend the Word of God through music and the spoken word by means of radio, television, records, tapes, conferences, literature, traveling concerts, home concerts, evangelistic campaigns, and through the use of other similar means.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
