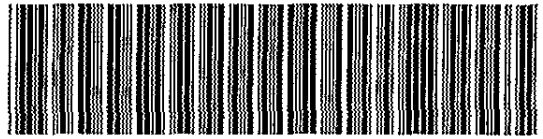

to

ARTICLES OF INCORPORATION
