TO WHOM IT MAY CONCERN:

On April 30, 1997, a check # 660, made payable to the Dept. of State was issued in the amount of \$61.25 and the necessary paperwork forwarded to Tallahassee. Sometime in late May the paperwork was sent back to us due the fact we did not have a third officer listed. The form was mailed back to Tallahassee on June 11, 1997.

Late October, 1997, the Notice of Administrative Dissolution or Revocation was received by our office.

Several phone calls were made to the Dept. of State inquiring as to why. It was determined (the last conversation on 11/10/97 with Andy Dunlapp) that Transportation Services Employee Special Funds Organization, Inc. never received the second mail back.

On November 11, our check number 660 was voided and a new check (#680) issued in the amount of \$61.25 (as suggested by Mr. Dunlapp) in hopes that the \$175.00 would be waived due to that fact that the "packet" was never received by our office after we mailed it back to Tallahassee on June 11, 1997.
