Pursuant to the provisions of Sections 617.1402 and 617.1403 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Dissolution:

Article I - Name of Corporation

The name of the corporation is North Florida Technology Innovation Corporation (hereinafter referred to as the "Corporation").

Article II - Date Dissolution Authorized

The dissolution of the Corporation was authorized on March 25, 1998.

Article III - Approval of Dissolution

The dissolution was unanimously approved by all of the members of the Corporation by written consent dated March 25, 1998, executed in accordance with Section 617.0701 of the Florida Statutes and the number of votes cast for dissolution was sufficient for approval. The dissolution was unanimously approved by all of the Directors of the Corporation by Written Consents last dated February 10, 1998, executed in accordance with Section 617.0821 of the Florida Statutes.

Article IV - Effective Date of Dissolution

The Corporation shall be dissolved effective upon the filing of these Articles of Dissolution.
