**TO WHOM IT MAY CONCERN:**

This law firm represents the non-profit corporation entitled, "The Women's Issues Network Foundation, Inc.". We have recently received the enclosed 1997 Annual Report for this non-profit corporation.

The form was sent to a former officer of the corporation, who no longer resides at the address to which it was addressed. Apparently, three attempts were made to serve the notice on her, but to no avail. Ultimately, the form was received by the corporation's Treasurer, but it was past the filing deadline.

As this non-profit corporation has very few assets, the payment of the increased fee for filings after September 17, 1997 would work an extreme and severe hardship on the entity. I have explained to the officers and directors that regardless of where the form is sent, the corporation still has an affirmative obligation to get the report filed timely each year. They now understand that, and will endeavor to timely file the report in all future years, but would respectfully request a waiver of the imposition of the increased filing fee for this year.
