EXHIBIT "A"

AMENDMENTS TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION

The original Declaration of Protective Covenants, Restrictions and Easements for Majestic Isles is recorded in Official Records Book 9026, at Page 504, in the Public Records of Palm Beach County, Florida. The Amended and Restated Declaration of Protective Covenants, Restrictions and Easements for Majestic Isles is recorded in Official Records Book 16291, at Page 683 in the Public Records of Palm Beach County, Florida. The Original Articles of Incorporation of Majestic Isles Association, Inc., are recorded in Official Records Book 9026, at Page 546 of the Public Records of Palm Beach County, Florida.

As indicated herein, words underlined are added and words struck through are deleted.

Item 1: Article IV of the Articles of Incorporation shall be amended by the creation of a new Paragraph D as follows:

D. No policies, rules or regulations may be based on the practice of any specific religion, sect or cult.

No facilities of the Association may be used for religious services. However, clubs with religious affiliations may use the facilities for meetings and functions.

The Board of Directors shall not make any decision or take any action, other than the enforcement of this restriction, that prevents the rights of the Association members to use the Association facilities on the basis of any religious law or belief.

Item 2: Article XII, Section A (1)(c) of the Articles of Incorporation shall be amended as follows:

(c) At such meeting, a vote of the Members shall be taken on the proposed amendment(s). The proposed amendment(s) shall be adopted upon receiving the affirmative vote of a majority of the Members present and voting at a duly called meeting.
