NOTICE IS HEREBY GIVEN that on January 15, 2023, an unauthorized person filed a **false 2023 Annual Report** for Orlando Health Medical Group, Inc. ("OHMG") online with www.Sunbiz.org. The unauthorized person listed his name as STEPHEN R. LING. Mr. Ling signed the false Annual Report under penalties of perjury, purportedly as Treasurer of OHMG, falsely claiming that he was "an officer or director of the corporation or the receiver or trustee empowered to execute this report as required by Chapter 617, Florida Statutes." Mr. Ling is not the treasurer of OHMG and is not an officer or director or receiver or trustee of OHMG. Mr. Ling has no official relationship or position with OHMG whatsoever. Mr. Ling falsely reported that the current mailing address of OHMG is 1150 Las Vegas Blvd. S., c/o Stephen Ling, Las Vegas, NV 89104 US. Mr. Ling improperly and without authorization deleted the names of the officers and directors and mailing address who and which had been properly listed by OHMG in its 2022 Annual Report filed on April 5, 2022.

OHMG is correcting the inaccuracies in Mr. Ling's false 2023 Annual Report by filing an Amended 2023 Annual Report on January 17, 2023.




