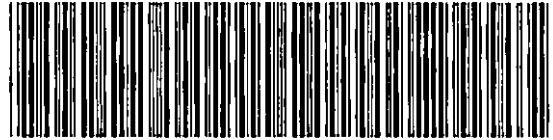


Re: Board Member Resignation Notice
