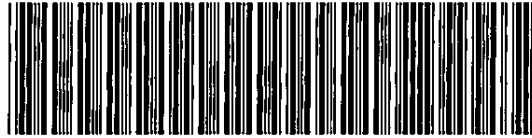

3. There were members entitled to vote on the proposed amendment.


