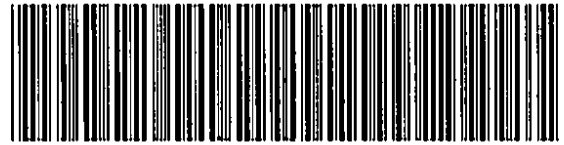

AMENDMENT TO THE AMENDED AND RESTATED
ARTICLES OF INCORPORATION
FOR
VILLAGE WALK HOMEOWNERS ASSOCIATION OF NAPLES, INC.

The Amended and Restated Article of Incorporation for Village Walk Homeowners Association of Naples, Inc. shall be amended as shown below:

Note: New language is underlined; language being deleted is shown in ~~struck through~~ type.

Article III, Sections (F), (G) and (I) of the Articles of Incorporation of Village Walk Homeowners Association of Naples, Inc. shall be amended to read as shown below:

- (F) To dedicate, sell or transfer all or any part of the Common Areas or to dedicate any of the Common Areas to any public agency, authority, or utility for such purposes and subject to such conditions as may be agreed to by the members. No such dedication, sale or transfer shall be effective unless the approval of at least two thirds (2/3rds) of the voting interest who are present and voting, in person or by proxy, at any annual or special meeting called for the purpose ~~the Voting Member Council shall have been obtained, as provided in paragraphs 4.7 and 4.8 of the Bylaws;~~
- (G) With the prior approval of at least two thirds (2/3rds) of the voting interest who are present and voting, in person or by proxy, at any annual or special meeting called for the purpose ~~the Voting Member Council as provided in paragraphs 4.7 and 4.8 of the Bylaws;~~ to borrow money, and mortgage, pledge, deed in trust, or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;

- (I) Subject to the prior approval of at least two thirds (2/3rds) of the voting interest who are present and voting, in person or by proxy, at any annual or special meeting called for the purpose ~~the Voting Member Council as provided in paragraph 2.10 of the Declaration;~~ to acquire (by gift, purchase or otherwise) own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, or otherwise dispose of real or personal property in connection with the affairs of the corporation;


