Our mission is completed and our dissolution (voted on by the members and the Board of Directors) is to be effective August 1, 1999. We have met all of our financial and other obligations.

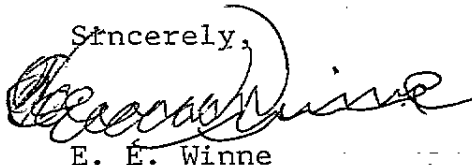
