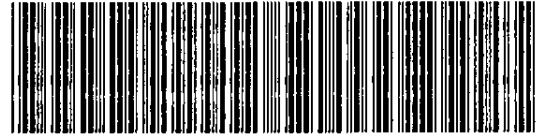

No pastor at anytime can ever come to Mt. Sinai Baptist Church, Inc. under a contract. The majority of the church can vote a pastor out at anytime after it has been announced three times before the church.

This amendment cannot have another amendment within 100 years from calendar year 2011. Neither the church nor the pastor can change anything in the church bi-laws within 100 years of calendar year 2011

No pastor can be president or trustee of the cooperation at anytime. No pastor or Deacon can be part of the Financial Committee at Mt. Sinai Baptist Church, Inc. This amendment cannot be canceled or deleted at anytime within 100 years of calendar year 2011.
