A Non-Profit Corporation

Amended and Restated Articles

Article One
Name

The name of the corporation is: *Wings Of Eagles International, Inc.*

Article Two
Principle Address

The principle address of the corporation is:
8201 Tomkow Rd.
Lakeland, Florida 33809

Article Three

The term of existence of this corporation is perpetual; the corporation will continue and operate in accordance with the revised articles upon filing with the Department of State, State of Florida.

Article Four
Purpose

The purpose of this corporation is as follows:

For clarification, impoverished people groups will be defined as: *Made poor or deprived of richness or strength; having limited or depleted resources to maintain quality of life. Having been reduced to poverty or become poverty-stricken as a result of social, economic, or physical living environment.*

- A. To provide education to impoverished people groups by building schools, adopting existing schools, aiding the operation of existing schools or providing consulting services for existing schools.
- B. The primary focus is Pre-kindergarten, Kindergarten and grades 1-12.
- C. Adult education: GED or equivalent, bible education and limited accredited classes.
- D. Operation of a food bank to aid in the distribution of food and household items to impoverished people groups.
- E. Operate a church as a means of spiritual discipleship.

- F. This corporation is organized and operated for religious and social purposes within the meaning of section 501(c) 3 of the Internal Revenue code.
- G. To carry on these actives in all states of the United States of America and around the world as the need presents.
- H. To acquire, buy, own, hold, sell, exchange or otherwise dispose of goods, chattels, effects, supplies and merchandise; to mortgage, lease, hypothecate, convey, exchange or dispose of as may be necessary or advisable for the purpose of *Wings Of Eagles International, Inc.* both real and personal; To acquire by gift, device, bequest or otherwise, property both real and personal, or otherwise each and every other power and right granted to a corporation NOT FOR PROFIT under the laws of the State of Florida.
- I. The corporation shall not engage in any actives not authorized by section 501 (c) 3 of the Internal Revenue code of 1954 or the corresponding provision of any future United States Internal Revenue code.
- J. No substantial part of the actives of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including publishing or distribution of statements) on behalf of a specific candidate for public office.

Article Five

The method of the election of the Board of Directors is set forth in the Bylaws. The affairs of the corporation are to be managed by the Board of Directors consisting of not less than three and not more than fifteen. The board of Directors shall, as soon as practicable after taking office elect a President, Vice-President, Secretary and Treasurer of the corporation from the members of the Board of Directors.

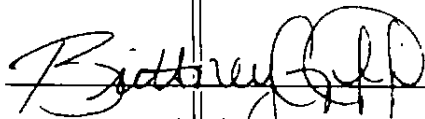
