### III. Qualification of Members; Manner of Admission:

- A. Qualifications of Members. Any person residing within the area of service of the present District 13 of the Department of Juvenile Justice, State of Florida, and/or the five counties of Marion, Lake, Sumter, Citrus and Hernando, may become a member of the Corporation by presenting to the Board of Directors a letter of recommendation for membership from his or her church or synagogue also confirming his or her membership therein or as pastor, minister or rabbi thereof; by endorsing and supporting the goals and purposes of the Corporation; by accepting the scriptures of the Judeo Christian heritage; by signing the covenant stating the goals, objective and purposes of the Corporation and by accepting the responsibilities of membership.

# B. Manner of Admission. Persons wishing to become members shall:

- 1) Present a request to become a member, in writing, to the Board of Directors accompanied by a letter of recommendation from his or her church or synagogue, which also confirms the applicant's membership therein; or as a pastor, minister, or rabbi thereof.
- 2) Participate in orientation for a three (3) month period as an associate member.
- 3) Accept the goals, objective and purposes of the Corporation. No more than three (3) persons from any one church or synagogue may serve as members of the Corporation at any time.

- C. <u>Associate Member</u>. An associate member is a member conditionally admitted without voting right, presently undergoing the three (3) month period of orientation and who has not signed the Covenant.
- D. <u>Full Member</u>. A full member is a member who has completed the orientation and has signed the Covenant.

#### IX. By-Laws:

- a. By Board or Members. Subject to Paragraph 3.02, the Board shall have the power to alter, amend, or repeal the By Laws or adopt new By Laws.
