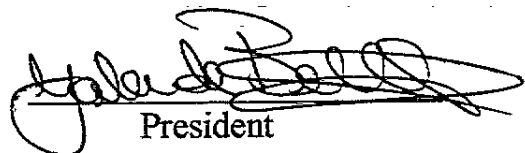


AMENDMENTS TO ^{ARTICLES}~~BY-LAWS~~

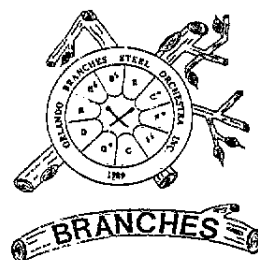
- 1) The purposes for which the Orlando Branches Steel Orchestra, Inc. is organized are exclusively charitable, educational and cultural within the meaning of section 501 (C) (3) of the Internal Revenue Code of 1986 or any corresponding provision of any future United States Internal Revenue Law. .
- 2) Notwithstanding any other provision of these Articles, This organization shall not carry on any activities not permitted to be carried on by any organization exempt from Federal income tax under section 501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future Internal Revenue Law.
- 3) Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within meaning of section 501 (C) (3) of the Internal Revenue Code of 1986 or corresponding section of any future federal tax code or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county: which the principal office of the corporation is located, exclusively for such purpose or to such organization or organizations, as said court shall determine which are organized and operated for such purpose.

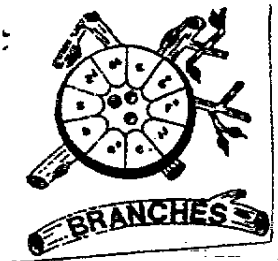


PREAMBLE

The purpose for which the corporations were formed are as follows:

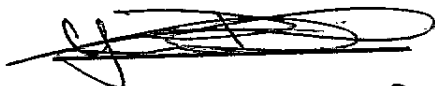
