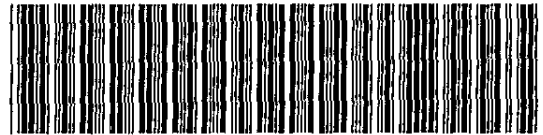

The purposes for which this corporation is formed are exclusively charitable, educational and scientific and consist of the following:

- 1.) To research issues affecting the revenue and budget of the State of Florida and their impact on Floridians and to publish, distribute and promote information so gathered.
- 2.) To educate policy-makers, community organizations, businesses, religious organizations, taxpayers and the general public regarding issues affecting the revenue and budget of the State of Florida and their impact on Floridians.
- 3.) To promote understanding among policy-makers, community organizations, businesses, religious organizations, taxpayers and the general public regarding issues affecting the revenue and budget of the State of Florida and their impact on Floridians.
- 4.) To promote understanding among policy-makers, community organizations, businesses, religious organizations, taxpayers and the general public regarding the impact of fiscal and budgetary decisions on Floridians, particularly lower and middle-income Floridians.
- 5.) To promote understanding among policy-makers, community organizations, businesses, religious organizations, taxpayers and the general public regarding income inequality, self-sufficiency, living wage, unemployment, the distribution of wealth, and similar issues within the state of Florida.
- 6.) To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, associations, trusts, institutions, foundations, or governmental bureaus, departments or agencies.
- 7.) All of the foregoing purposes shall be exercised exclusively for charitable, educational and scientific purposes in such a manner that the Corporation will qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
