

The objective of programming is to emphasize the importance of: a safe, non-threatening environment; diversity in culture and background; positive interaction with peers & authority figures; social and personal growth; peaceful conflict resolution, and good hygiene and proper grooming standards. Additionally, it shall also enhance and expand existing programs by providing centralized access to resources, collaborative opportunities, and various creative community efforts. These activities are driven by a strategic plan.

The organization is nonprofit, nonpartisan and nonsectarian, and abides by the rules set forth as an exempt Corporation under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. This Corporation will have the powers as may be stated in its Articles of Incorporation, and such powers as are adopted or may be granted hereafter by law. The Truth for Youth is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The Corporation promotes and advocates African American culture for youth in Northwest Florida and through the state.

Truth for Youth showcases artist, scholars, historians, dancers, poets, and musicians to celebrate gifted African American youth. Through quality programs, Truth for Youth offers exhibits in the areas of visual arts and humanities, performing arts programs, films and education lectures, all highlighting African American


