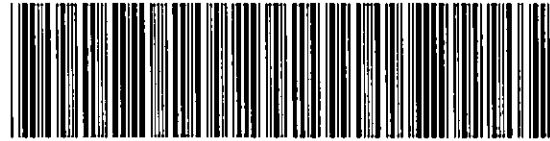

**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
SUNCOAST YOGA TEACHERS ASSOCIATION, INC.**

Pursuant to the provisions of sections 617.1002 and 617.1006, Florida Statutes,
SUNCOAST YOGA TEACHERS ASSOCIATION, INC., a Florida Not For Profit
Corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is SUNCOAST YOGA TEACHERS
ASSOCIATION, INC.

2. Article I of the Articles of Incorporation, which states the name of the
corporation, is deleted in its entirety and replaced as follows:

"ARTICLE I

The name of the corporations is: FLORIDA YOGA TEACHERS
ASSOCIATION, INC."

3. The members of the corporation are not entitled to vote on amendments to the
Articles of Incorporation.

4. The foregoing amendment to the Articles of Incorporation was approved and adopted by the unanimous vote of the corporation's Board of Directors at a meeting held on July 14, 2017.
