ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF SPRING RIDGE HOMEOWNERS ASSOCIATION, INC. OF APO

SPRING RIDGE HOMEOWNERS ASSOCIATION, INC., OF APOPKA Florida not-for-profit corporation, by and through its President Raymond Bradick and Secretary Ralph Singleton, hereby adopts amendments to its Articles of Incorporation as hereinafter set forth.

- 1. The name of the corporation is SPRING RIDGE HOMEOWNERS ASSOCIATION, INC. OF APOPKA.
- 2. The texts of each amendment and the articles and paragraphs effected in the Articles of Incorporation are as follows:

Duties

In addition to the other duties and powers, the Association shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River Water Management District permit no. 40095-0309 requirements and applicable District rules, and shall assist in the enforcement of the restrictions and covenants contained herein.

Powers

In addition to the other powers established in the Articles and Declaration, the Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the surface water or stormwater management system.

ASSESSMENTS

In addition to the use of assessments for that set forth in the Declation, the assessments shall be used for the maintenance and repair of the surface water or stormwater management systems including but not limited to work with retention areas, drainage easements.

DISSOLUTION

Amend Article IX by inserting the following at the end of the existing language. In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, <u>F.A.C.</u>, and be approved by the St. Johns River Water Management District prior to such termination dissolution or liquidation.

3. The number of votes cast by the members entitled to vote for the amendment was sufficient for approval. The vote occurred on the 5th day of January, 1995.
