Due to several unavoidable circumstances, including flooding, and other matters beyond my control, I have re-located twice between January, 1997 and January, 1998.

However, despite these unfortunate occurences, I have been able to respond to the deadlines for filing our corporation's annual report for 1997 and 1998. Unfortunately, the report filed for 1998 included a check for \$61.00, not the required \$61.25. The report with the check for \$61.00 was returned to me during the Summer. In September, after a bout with an illness, I called your office and was told that it was not too late to re-submit my report with the correct fee of \$61.25. The next day I resubmitted the application with a check for the required \$61.25.

Now, two months later, I am told that the corporation has been administratively dissolved for failure to file the 1998 annual report, and the fee for re nstatement is \$236, including the \$61.25 annual dues paid in September.

Please know:

1. I was never informed about the dispensation of the report mailed in September, or whether the \$61.25 replacement check was received.

2. I would like to appeal the administrative dissolution of our corporation and need your advice on how to proceed.
