AMENDED ARTICLES OF INCORPORATION OF IGLESIA JUAN 3:16, INC. (CHURCH JUAN 3:16, INC)

We, the undersigned persons of the State of Florida, all of whom are of legal age, each being competent to contract, herby form ourselves and our successors into a corporation not for profit under the Laws of the State of Florida, and hereby adopt the following Articles of Incorporation:

ARTICLE I – NAME

The name of this Corporation shall be: IGLESIA JUAN 3:16, INC., (Church John 3:16, Inc.), Tampa, Florida, with its principal place of business located at 7601 N. Rome Avenue, Tampa, Hillsborough County, Florida. The Registered Agent is Porfidio Acevedo, whose address is 10013 Colonnade Drive, Tampa, Florida 33647.

ARTICLE II - PURPOSE

The general nature, object and purpose of this corporation is as follows:

A. To establish and maintain a place for the worship of Almighty God, our Heavenly Father to provide for Christian fellowship for those of like precious faith, were the Holy Ghost may be honored according to our distinctive testimony; to assume our share of responsibility and the privilege of propagating the gospel of Jesus Christ by all available means, both at home and abroad.

ARTICLE III - PROPERTY

The Corporation shall have the power to buy, acquire, and hold title in fee simple, in trust, or otherwise, to both real and personal property, and improve, encumber, sell, convey and dispose of all such property, to borrow money, execute notes, bonds, and other evidences of indebtedness and to secure the same by mortgages and deeds of trust, annuity bond, and other instruments of indebtedness and to pay interest thereon, to improve, adopt, and use property held by it for: The said Church corporation or the income therefrom in the religious, educational, benevolent, or social activities of the said corporation or its successor without financial profit to its members except as may be necessary in the payment of salaries, or other compensation for services rendered, and the corporation shall have the power to crect and maintain buildings to be utilized by the said church, for the worship of God, for the training in Christian faith, and to build and maintain residences for the use and occupancy of ministers of said Church corporation, in conformity with the by-laws of said corporation and all the power a right granted to Corporations Not For Profit under the laws of the State of Florida.



ARTICLE IV - MEMBERSHIP

Th members of the corporation shall be all members in good standing at any given time of the said Church corporation of Florida. Provided, however, neither the incorporators nor the members of the corporation shall have any vested right, interest, or privilege of, in or to the assts, functions, affairs or franchises of this corporation, or any right, interest of privilege which may be inheritable, or shall continue after his membership ceases in the aforenamed corporation. The corporation shall not have the power to buy, mortgage, sell encumber or deed or dispose of any property which it may acquire, without the consent or direction of a two-third (2/3) majority vote of the members at a duly called business meeting.

ARTICLE V - TERM

This corporation shall exist perpetually or until dissolved by due process of the law.

ARTICLE VII – OFFICERS
