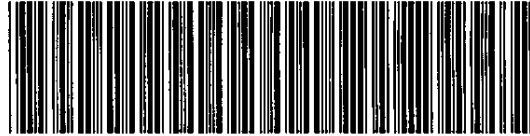

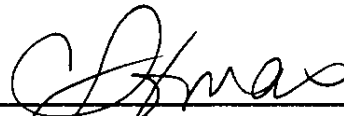

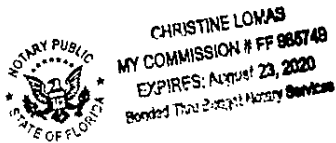

**TO**  
**ARTICLES OF AMENDMENT**  
**OF**  
**ESTATES AT ALOMA WOODS HOMEOWNERS ASSOCIATION, INC.**

1. ARTICLE VIII of the ARTICLES OF INCORPORATION is amended to read as follows:

**ARTICLE VIII**  
**BOARD OF DIRECTORS**

The affairs of this Association shall be managed by a Board of Directors consisting of no less than three (3) nor more than nine (9) Directors ~~who need not be members of the Association provided, however ;~~ **who must be Members of the Association in good standing who are not delinquent in assessments or have any violations outstanding at the time of nomination. Members of the Board of Directors who are or who become sixty (60) days delinquent in any amount due and owing to the Association are not qualified to serve on the Board and have abandoned their positions. This provision is in addition to current law, and supersedes any future conflicting statute or rule.** The Board shall consist of an odd number of Directors. The number of Directors may be changed by amendment of the Bylaws of the Association. The initial Board of Directors shall consist of the following three (3) Directors, who shall serve until the appointment of their successors as provided in the Declaration or the election of their successors as provided in the Bylaws, as the case may be: . . .
