AMENDMENTS TO
ARTICLES OF INCORPORATION
FOR
GATEWAY OF ABUNDANT LIFE SYSTEMS INC.
adopted: 8th April, 1999

ARTICLE IV of the original Articles filed on 21st Nov. 1994 has been amended to include the following text:

- A. The purposes for which the Gateway Of Abundant Life Systems Inc. is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- C. In the event of dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code of 1986 or any corresponding section of any future Federal Tax Code.; or shall be distributed to the Federal, State or Local government for a public purpose. Any such assets not so disposed of, shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
