To Whom It May Concern,

In September of 1998, I checked my files and realized that I had not yet received the corporation certificate for 1998. I called the Division of Corporations and explained to them that I mailed out the appropriate fee and paper work in April of 98. The check was not cashed and they had nothing on file but said that they were backlogged. I checked again in November, still nothing. At that point someone said they would send me some paperwork to fill out and to send a check. I never received anything until January 9th which was the Notice of Administrative Dissolution. I then called back the Division of Corporations and they said to fill out the form and include a letter explaining what happened and to ask to waive the late fees and enclose the fee for 1998 and 1999, which is enclosed.
