ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SARASOTA FOOTBALL CLUB, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation of Sarasota Football Club, Inc. document # N94000006064 on November 16, 2015. The board of directors and it's members adopted these amendments by a vote sufficient for approval.

ARTICLE I

The purposes for which the corporation is organized are:

The purposes for which the corporation is organized are to promote a soccer program for both youth and amateur programs in the Sarasota, Bradenton and Venice Florida area, to encourage the players in their endeavors, to raise funds to be expended solely in providing needed facilities, equipment, services and those things required for, and connected with, a first class sports program, to stimulate and promote greater community interest, participation and enthusiasm in the soccer program, to unite ourselves for good fellowship between athletic participants and our members, to provide a cooperative bond between the membership of this organization, coaches, and the administration, with active and working participation that will improve, enhance and elevate the soccer program of this area.

ARTICLE X

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
