ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

1. Article IV of the Articles of Incorporation of Virginia Gaylord Neely Charitable Foundation, Inc., is deleted in its entirety and replaced as follows:

ARTICLE IV. TERM OF EXISTENCE
