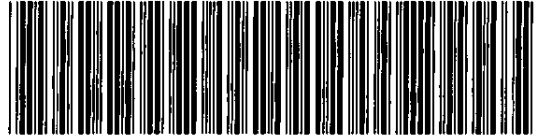

ARTICLE III


Purpose(s)

6. Bible college - CPR of Evangelical Bible Seminary College

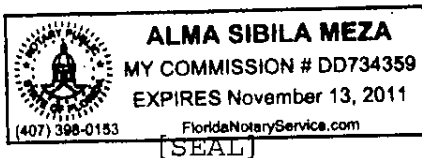
