ARTICLES OF AMENDMENT TO THE ARTICLES OF

INCORPORATION OF

GAINESVILLE AREA TENNIS ORGANIZATION, INC.

Se Oct 17 CO Pursuant to the provisions of § 617.1006, Fla. Stat. the undersigned not-for-profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is GAINESVILLE AREA TENNIS ORGANIZATION, INC.
- 2. The following amendments of the Articles of Incorporation were adopted by the Board of Directors of the corporation on the 29th day of November, 1998.
- The Articles of Incorporation will be amended as follows: 3.
 - Article I of the Articles of Incorporation will read as follows: The name of the corporation is SUWANNEE VALLEY TENNIS ASSOCIATION, INC.
 - b. Article II of the Articles of Incorporation will read as follows: The street address of the corporation's present registered office is 4259 S.E. 79th Street, Ocala, Florida 34480.
 - Article III of the Articles of Incorporation will read as follows: c.

The purpose of the corporation shall be to promote the development of tennis as a means of healthful recreation and physical fitness for all residents of the Suwannee Valley and to cooperate with the United States Tennis Association and other Associations in pursuit of these aims.

Notwithstanding any other provision of these Articles, the purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

- 4. All other portions of the Articles of Incorporation not expressly amended hereby will remain unchanged.
- 5. There are no members entitled to vote on this amendment. This amendment was adopted by the Board of Directors.
