# ARTICLE ONE

# Namo

The name of the corporation is Innfields Homeowners Association, Inc.

# ARTICLE TWO

# Duration

The term of existence of the corporation is perpetual; and the corporate existence will commence on the filing of these articles by the Department of State.

# ARTICLE THREE

#### Purpose

The corporation is organized for the purpose of providing a homeowners association for the benefit of the owners of real property in Innfields Subdivision, as recorded in Plat Book 53, Pages 33-1 through 33-5, public records of Hillsborough County, Florida, and to otherwise engage in any lawful purpose or purposes not for pecuniary profit.

# ARTICLE FOUR

#### Directors

There shall be three members of the Board of Directors of the corporation. The names and addresses of the persons who are to serve as directors until the first election thereof are as follows:

The method of election of directors shall be stated in the Bylaws of the corporation.

# ARTICLE FIVE

# Rogistored Office and Agent

The initial registered office of the corporation shall be located at 11607 Innfields Drive, Odessa, Florida 33556. The initial registered agent of the corporation at that address shall be Kim A. Griffin.

#### ARTICLE SIX

#### Mombers

The corporation shall have members. Membership and admission into the corporation shall be open to all persons owning a lot in Innfields Subdivision as created by the plat referred to in Article Three herein. The Bylaws shall provide for the specific criteria and requirements for membership but shall insure that every lot owner shall have the right to be a member of the association.

#### ARTICLE SEVEN

#### Voting

The recorded owner of each lot, provided said owner shall have satisfied the requirements of membership as stated in the Bylaws, shall be entitled to one (1) vote on matters coming before the general membership for vote. In the event any lot is owned by more than one person, that lot shall nevertheless be entitled to a single vote. In the event a person owns more than one lot, that person shall be entitled to a vote for each lot owned, cumulatively.

#### ARTICLE EIGHT

# <u>Amendments</u>

There shall be no amendment of these Articles or the Bylaws of the corporation except with a vote of seventy-five (75%) per cent of the members qualified to vote.
