Pursuant to the provisions of Section 617.1006, Florida Statutes, Volusia/Flagler Family Young Men's Christian Association, Inc. formerly known as West Volusia Family Young Men's Christian Association, Inc., a Florida Not for Profit Corporation ("Corporation") adopts the following amendment(s) to its Articles of Incorporation:

1. This Amendment hereby confirms that the Corporation has changed its name to Volusia/Flagler Family Young Men's Christian Association, Inc. via the Articles of Merger filed on June 20, 2008 with the Florida Secretary of State.
2. Article II of the Corporation's Articles of Incorporation presently reads in part:  
  
"The purpose for which the corporation is organized is to develop, establish, and administer a Young Men's Christian Association (YMCA) for Deland/ West Volusia County, Florida."

And shall be amended to read as follows:


