<u>Verbiage to motion for amendment updating the Articles of Incorporation to</u> comply with the 501C3 specifications

Current purpose: The purpose of this corporation shall be civic, literary, social, scientific and philanthropic, and to advance the general cultural and social relationships of its members and guests, to aid in the betterment of civic conditions, and to promote higher social and moral standards; and to transact any and all lawful business and to do all other things incidental to them or connected with them that are not forbidden by the Florida corporations laws or by other law, or by the Articles of Incorporation, and to carry out the said purposes in any state, territory, district or possession of the United States of America, or any foreign country

Current dissolution: None

<u>Updated purpose:</u> The purpose for which the organization is organized is exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501C3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Not withstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under Section 501C3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States revenue law.

<u>Updated dissolution</u>: The object and purpose of the Organization being entirely charitable, no part of its earnings will inure to the use or benefit of an individual. In the event this organization should be dissolved for any reason, any remaining assets will be distributed to the GFWC Florida Federation of Women's Clubs to which this club belongs, as long as the Federation remains within the scope of IRS Section 501C3 or any amendments thereto.
